(WAITING RESTRICTIONS AND STREET PARKING PLACES)

(AMENDMENT NO. 13) ORDER 2009

THE KENT COUNTY COUNCIL acting as the local highway authority and in exercise of its powers under Sections 1, 2 and 124 and of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby makes the following Order:-

AMENDMENTS

- (1) The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) Consolidation Order 2007 is hereby amended as follows:-

IN THE ARTICLES OF THE ORDER

- (2) In the Table to Article 8 (Prohibition of Stopping on Taxi Ranks) there was added the following item:-

- (f) *From a point 2 metres north west of a point in line with the common boundary of Nos. 30 and 32 Albert Road for a distance of 6.3 metres in a south easterly direction.*
- (g) *From a point 19.8 metres south east of the common boundary of Nos. 30 and 32 Albert Road to a point 63 metres west of the western kerb line of North Street.*

- (a) *From a point 47.5 metres west of the western kerb line of North Street to a point 31.8 metres west of the western kerb line of North Street;*
- (b) *From a point in line with the western kerb line of north street for a distance of 10 metres in a western direction.*

- (e) *From a point 20.3 metres south of a point in line with the common boundary of Nos. 41 and 43 Albert Road to a point 0.5 metres north west of a point in line with the common boundary of Nos. 37 and 39 Albert Road;*

- (f) *From a point 9.4 metres south east of a point in line with the common boundary of Nos. 37 and 39 Albert Road to a point 3.4 metres south east of a point in line with the common boundary of Nos. 31 and 33 Albert Road;*
 - (g) *From a point 3.6 metres north west of a point in line with the common boundary of Nos. 23 and 25 Albert Road to a point 1.5 metres north west of a point in line with the common boundary of Nos. 15 and 17 Albert Road;*
 - (h) *From a point 3.2 metres south east of a point in line with the common boundary of Nos. 15 and 17 Albert Road to a point 49.8 metres west of the western kerb line of North Street.*
- (2) *On the northern side from a point a point in line with the western kerb line of North Street for a distance of 16 metres in a western direction.*

(b) The following to be added;

ALFRED ROAD *On both sides from a point in line with the south western kerb line of Newtown Road south westwards for a distance of 10 metres.*

(c) All references to DOVER PLACE be deleted and replaced with the following;

DOVER PLACE *On both sides for its entire length*

(d) All references to DRUM LANE be deleted and replaced with the following;

DRUM LANE (1) *On the eastern Side*

(a) *From the junction with New Rents southwards to a point 2.7 metres south of the northern building line of New Rents;*

(b) *From a point a point 20.8 metres south of the northern building line of New Rents southwards for a distance of 2 metres;*

(c) *From a point 31 Metres south and then east of the northern building line of New Rents to a point 27 metres north east of the northern kerb line of Regents Place including both sides of access road to the service area located at the rear of Nos. 1-11 New Rents.*

(d) *From the junction with Regents Place / Apsley Street north eastwards to a point 17 metres north east of a point in line with the north eastern kerb line of Regents Place.*

(2) *On the western side*

(a) *From the junction with Regents Place / Apsley Street north eastwards to a point 19.5 metres north east of a point in line with the north eastern kerb line of Regents Place;*

(d) *From a point 12.3 metres east of a point in line with the eastern wall of No. 15 Hardinge Road to a point 0.1 metres west of the western building wall of No. 19 Hardinge Road;*

(d) *From a point 0.7 metres north west of a point in line with the common boundary of Nos. 66 and 68 Kent Avenue to a point opposite and in line with the common boundary of Nos. 75 and 77 Kent Avenue;*

(e) *From a point 10 metres south east of a point opposite and in line with the common boundary of Nos. 75 and 77 Kent Avenue to the junction with Sturges Road.*

(2) *On the south western side*

(a) *From a point in line with the south eastern kerb line of Magazine Road for a distance of 10 metres in a south easterly direction;*

(b) *From a point 0.1 metres north west of a point in line with the common boundary of Nos. 35 and 37 Kent Avenue to a point 0.4 metres north west of a point in line with the common boundary of Nos. 39 and 41 Kent Avenue;*

(c) *From a point 1.0 metre north west of a point in line with the common boundary of Nos. 47 and 49 Kent Avenue to a point 1.0 metres south east of a point in line with the common boundary of Nos. 49 and 51 Kent Avenue;*

(d) *From a point 4.4 metres south east of a point in line with the south east wall of No. 63 Kent Avenue to a point 1.4 metres south east of a point in line with the north western building line of No. 69 Kent Avenue;*

(e) *From a point 0.1 metres north west of a point in line with the south eastern building line of No. 79 Kent Avenue to its junction with Sturges Road.*

On both sides from the western roundabout at the junction with Romney Marsh Road, eastwards to a point 15 metres south east of a point in line with the south eastern kerb line of Alfred Road

(south of Ring-Road)*

(1) On the eastern side

(a) *From its junction with High Street to a point 24.5 metres north of the northern kerb line of High Street;*

(b) *From a point 44 metres north of the northern kerb line of High Street to a point 13 metres north of the southern flank wall of 14 North Street;*

(c) *From a point 43 metres north of the southern flank wall of No. 14 North Street to a point 47 metres north of the southern flank wall of No. 14 North Street;*

(d) *From a point 53 metres north of the southern flank wall of No. 14 North Street to a point 55.5 metres north of the southern flank wall of No. 14 North Street;*

- (c) *From a point in line with the north eastern wall of No. 94 Western Avenue to a point 2.4 metres south west of a point in line with the common boundary of Nos. 90 and 92 Western Avenue;*
- (d) *From a point 1.5 metres south west of a point in line with the common boundary of Nos. 64 and 66 Western Avenue to a point 4.3 metres north east of a point in line with the common boundary of Nos. 64 and 66 Western Avenue;*
- (e) *From a point 1.4 metres south west of a point in line with the common boundary of Nos. 60 and 62 Western Avenue to a point 4 metres south west of a point in line with the common boundary of Nos. 58 and 60 Western Avenue;*
