With thanks for your message.

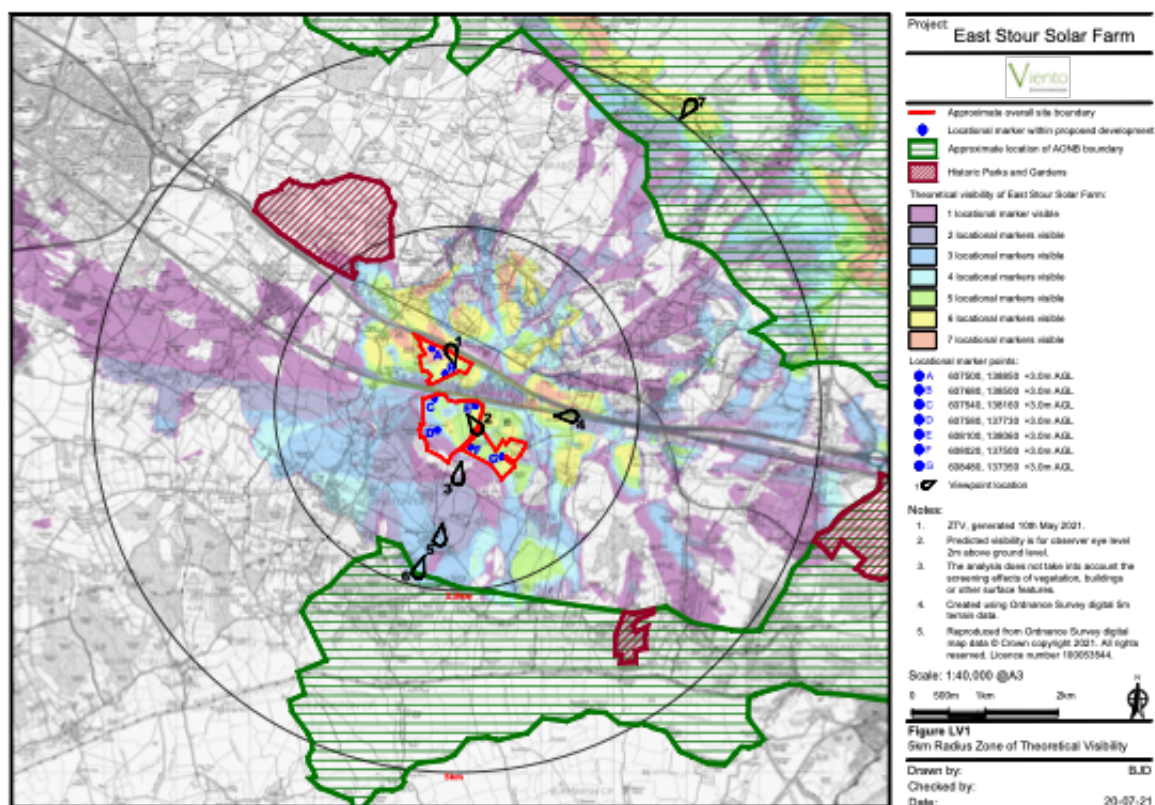
I was on leave at the end of last week so apologies for the delay in responding.

Dear Ian

Thanks for getting in touch.

We welcome the inclusion of viewpoints from the AONB in the LVIA. I'm happy with the proposed VP 6 at Postling Green but wonder if views from the escarpment of the Kent Downs could be revisited – this is where any impacts are more likely to be felt, although with the intervening distance I'm hopeful that impacts would not be significant.

I'm concerned that there would not be clear views from VP 7 due to intervening vegetation. In view of the importance assigned to views from the escarpment and the presence of the North Downs Way, I would also ideally like to see more than one VP included from this direction. Suggested alternatives would be:

- From Wye Downs Nature Reserve approx. grid ref 607865 145288
- From the NDW at approx. grid ref 610014 142772 (our No 1 choice)
- From the NDW in the vicinity of Farthing Common, or just north of it, approx. 613504 140609
