ROAD TRAFFIC REGULATION ACT 1984

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1, 2, 3, 4, 5, 19, 32, 35, 36, 45, 46, 49, 51, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following Order:-

1. This Order shall come into operation on the day of 2025 and may be cited as "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 (Amendment No.21) Order 2025" ("this Order")
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023" ("the Order of 2023") shall have effect as though:

Notice is given that THE KENT COUNTY COUNCIL acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), the Traffic Management Act 2004 and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby proposed to make the following Order:-

The effect of the made Order will be to introduce or amend existing disabled persons parking bays, new no waiting restrictions and a time restricted bay:

Roads in the Borough of Ashford

Cryol Road/Cryol Place, Ashford – 56.5m of double yellow lines

Dover Place, Ashford – Loading bay changed to a time restricted bay (20 minutes maximum stay, no return within 2 hours)

Bentley Road, Ashford – The formalisation of an existing disabled persons parking bay outside number 29

Clynton Way, Ashford – The formalisation of an existing disabled persons parking bay outside number 14

Jemmett Road, Ashford – The formalisation of an existing disabled persons parking bay outside no.153

Milne Road, Ashford – The removal of a disabled persons parking bay outside no.2

Osborne Road, Ashford – The removal of two disabled persons parking bays between no.220-222

Riverside Close, Ashford - The formalisation of an existing disabled persons parking bay at the side of no.17 Pound Lane

Rogersmead, Tenterden – The formalisation of an existing disabled persons parking bay at the side of no.24 Rogersmead

William Road, Ashford - The removal of a disabled persons parking bay outside no. 24

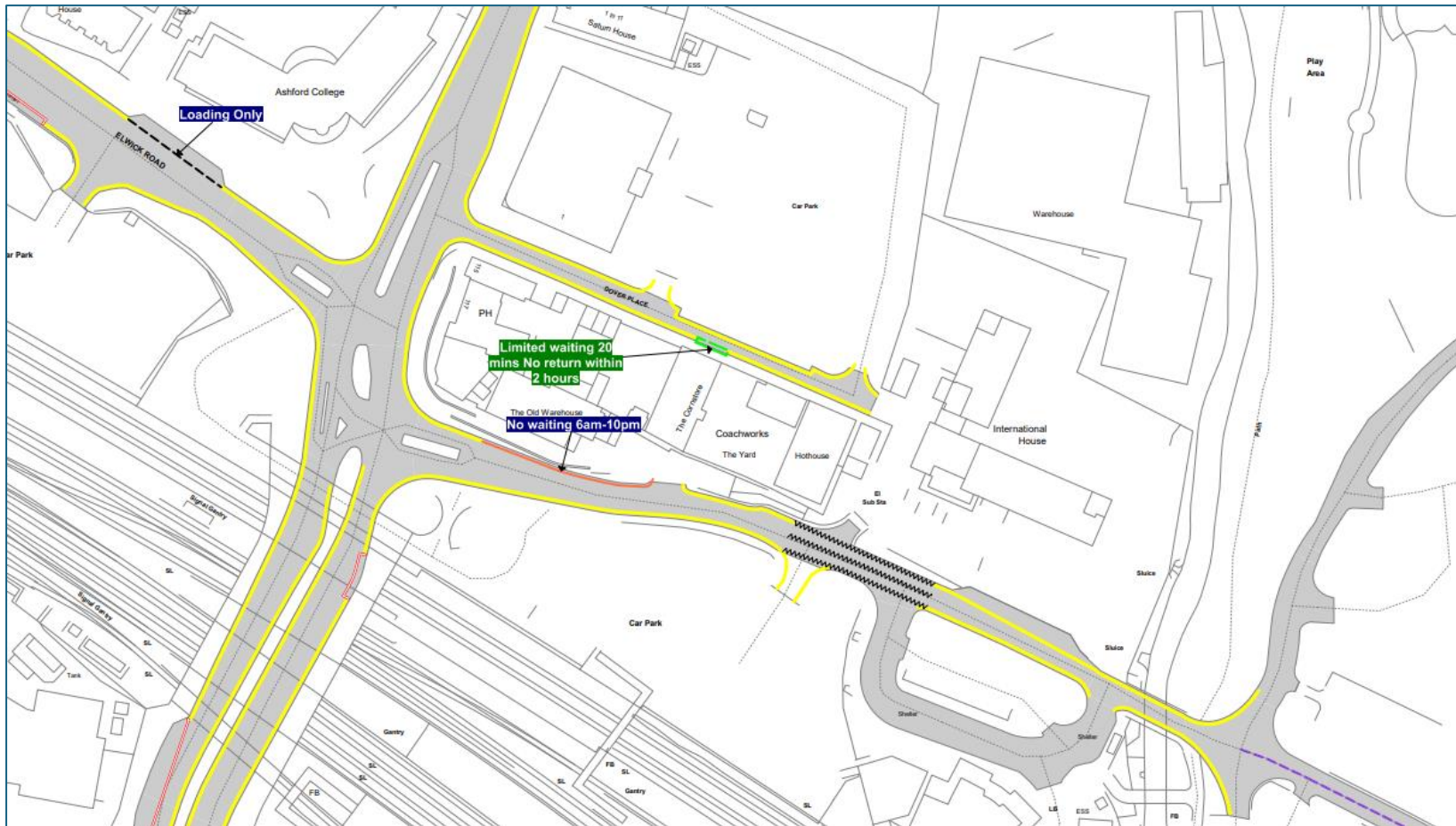

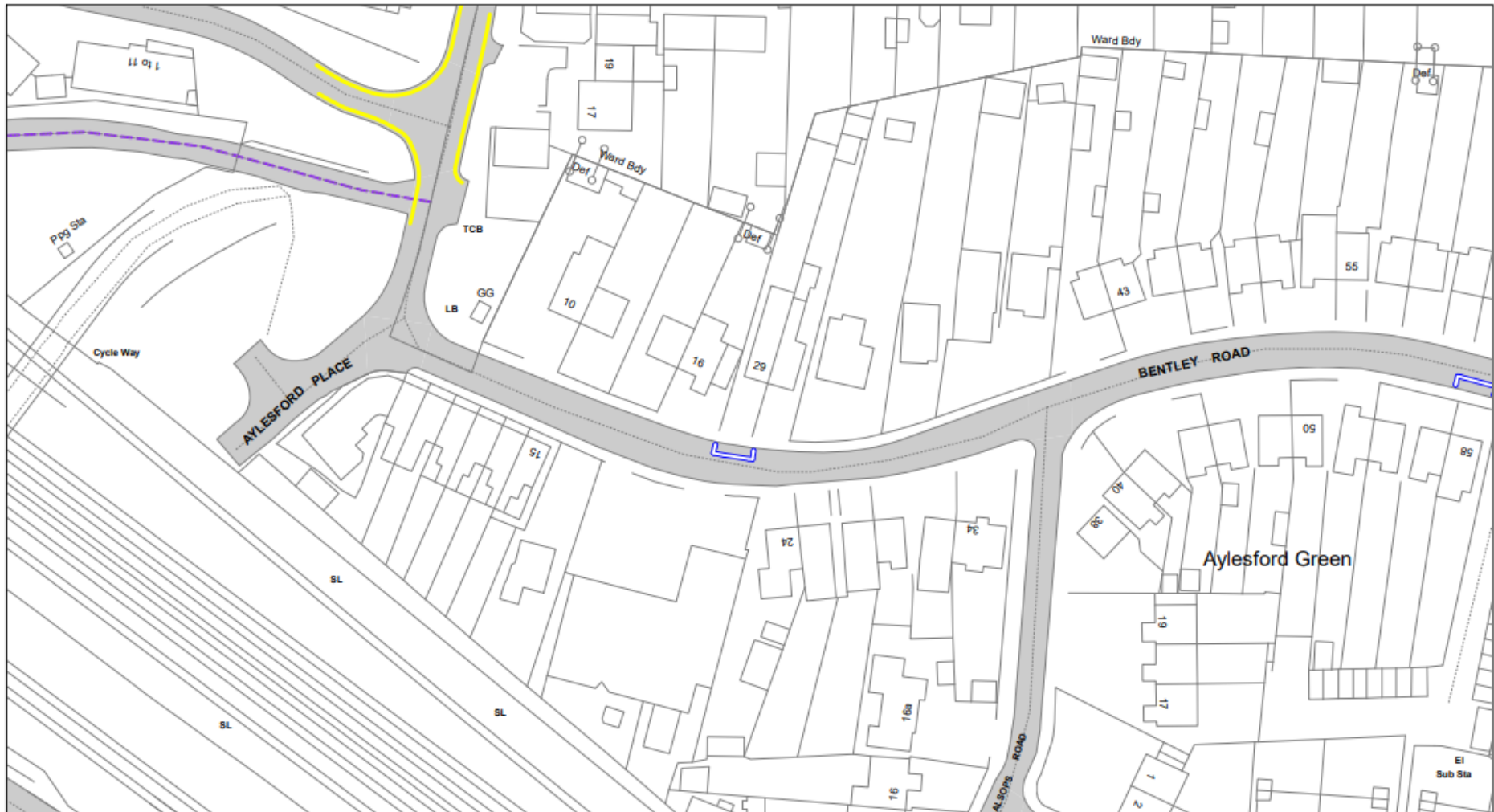
Cryol Road & Cryol Place



Dover Place



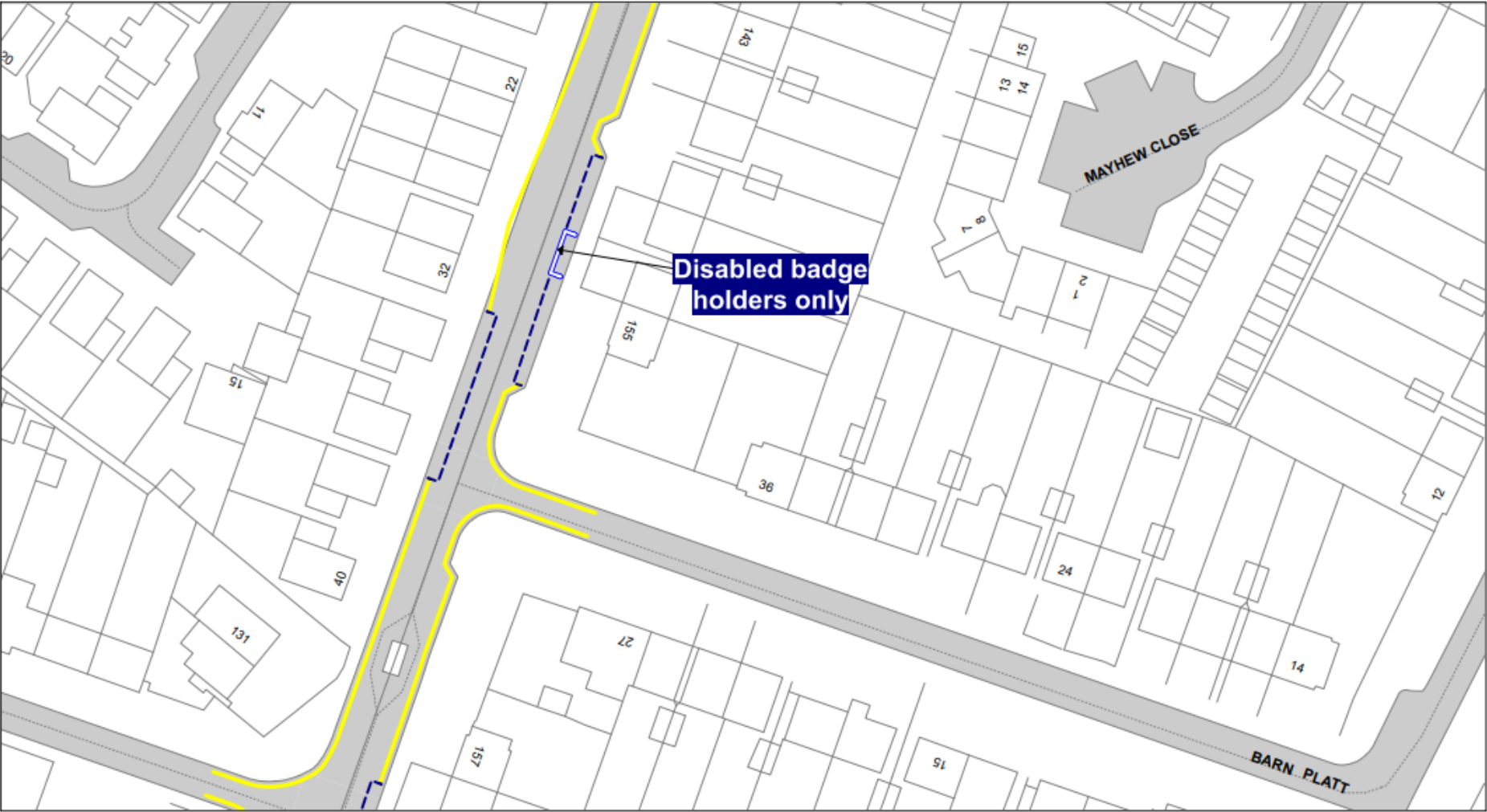
Bentley Road

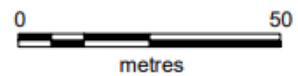


Clynton Way
